REVIEW PROCESS

PREFERRED CONDITIONS OF MANUSCRIPTS

The ACTA ANTIQUA strives to publish high quality papers. To ensure this goal, we apply some basic principles when reviewing a manuscript. Not fulfilling these principles may lead to desk rejection of a submitted manuscript.

REVIEW OF THE MANUSCRIPTS

In case the handling editor finds the manuscript suitable to be considered for publication in ACTA ANTIQUA, then it will undergo both internal review by members of the editorial or advisory board and external peer review at least by one expert chosen avoiding any conflict of interest. The peer review is single blind; that is, the reviewer is aware of the identity of the authors while the reviewer's identity is hidden to the authors.

Unpublished results are treated strictly confidentially.

COPYRIGHT AND LICENCE POLICY

OPEN ACCESS

Authors of the ACTA ANTIQUA can optionally choose Open Access appearance. With this choice, readers can read, download, copy, distribute, print, search or link to the full texts of articles, or use them for any other non-commercial lawful purpose. Such articles are distributed under Creative Commons Attribution-NonCommercial 4.0 International Licenses.

Authors not choosing Open Access publication are expected to sign the Copyright Transfer Form available [here](#).

SELF-ARCHIVING

The Author is entitled to self-archive the preprint version of his/her manuscript. The preprint version is the Author's manuscript or the galley proof or the Author's manuscript along with the corrections made in the course of the peer review process. The Author's right to self-archive is irrespective of the format of the preprint (.doc, .txt, .pdf) version and self-archiving includes the free circulation of this file via email or publication of this preprint on the Author's webpage or on the Author's institutional repository with open or restricted access. When self-archiving a paper, the Author should clearly declare that the archived file is not the final published version of the paper, he/she should quote the correct citation and enclose a link to the published paper ([http://dx.doi.org/\[DOI of the Article without brackets\]](http://dx.doi.org/[DOI of the Article without brackets])).

AUTHOR CHARGES

If choosing the optional Open Access appearance, corresponding author of every manuscript submitted after Feb 1, 2020 is requested to pay the *Article Processing Charge* (APC) of 900 EUR (including VAT) to cover the publishing costs of the paper.

In accordance with the agreement between the [Electronic Information Service National Programme](#) (EISZ) and Akadémiai Kiadó, papers with a corresponding author affiliated to a member institution subscribing to the journal package of Akadémiai Kiadó, can be published with no fee.

Akadémiai Kiadó offers 50% discount for Editorial Board members, and institutions of low- and middle-income countries. Discounts may not be combined. A limited number of waivers is available.

Manuscripts with outstanding payment will not be published until the balance is cleared. Once your paper is accepted for publication in ACTA ANTIQUA, and the authors made the Open Access choice, you will be requested to enter our online payment platform (<http://apc.akademiai.hu>), where after registration You can upload license agreement and transfer the fee. Article processing will commence after the amount due has been remitted to our account. (Please note that there is no peer review charge, the only applicable fee is the article processing charge for authors of accepted papers who made the OA choice.)

ETHICAL STATEMENT

ACTA ANTIQUA and Akadémiai Kiadó are committed to the ethical practices in science publishing and therefore follow the COPE [Code of Conduct for Journal Editors](#) as well as the [Code of Conduct for Journal Publishers](#). All authors are expected to be aware and follow the [Ethical Guide of Akadémiai Kiadó](#), conform to the highest standards of ethical conduct in the submission of accurate data, acknowledging the work of others, and divulging potential conflicts of interests.

PREPARATION OF THE MANUSCRIPTS

MANUSCRIPTS

Manuscripts should be written in clear, concise, and grammatically correct English, French, German, Italian, Latin or Spanish. Any format of Word for Windows (.doc, .docx or .rtf) or LibreOffice are accepted. In order to eliminate any problem of transfiguration a .pdf-version is also requested.

TITLE PAGE

The title should be concise and informative. This is preceded by the first name(s) and surname of the author(s). The name of the institution the author works at and the exact mailing address of the author should be given at the end of the paper.

TEXT

Authors are requested

- to use footnotes to be inserted to the electronic file of the study;

- not to give bibliography at the end of the paper and to refer to it, but to quote works in the footnotes;
- not to write *op. cit.* and the like, but to give the number of the footnote where the work was first mentioned in round brackets after the name of the author, then the page(s) referred to, e.g. Smith (n. 12) 18-21;
- when referring to books or cyclopaedias, to give the number of the volume quoted in Roman numerals;
- when referring to cyclopaedias, to arrange data as follows:
name of the author, in, title of the cyclopaedia (abbreviated, if possible), number of volume, year of publication in parentheses, number of pages or column(s), comma, s.v. title of the article, e.g. Ed. Schwartz in RE I (1894) 2868, s.v. Apollodoros;
- when referring to papers in periodicals, to arrange data as follows:
name of the author, colon, title of the paper, period, title of the periodical abbreviated as in *l'Année philologique*, number of the volume quoted in Arabic numerals, year of publication in parentheses, number of pages from-to (avoid, please, references, like 125 ff. or *passim*), e.g. J. Harmatta: The Language of the Southern Sakas. *Acta Ant. Hung.* 32 (1989) 299-307;
- when quoting Greek and Roman authors, collections of fragments, papyri, etc., to use the abbreviations of Liddell-Scott-Jones and of Oxford Latin Dictionary, resp.;
- not to give long titles to the articles, if possible.

PROOFS

Pdf proofs will be sent to the corresponding author, who is requested to return it as soon as possible. If the editors do not receive sheets within a reasonable time, the text will be corrected based on the manuscript, but they decline all responsibility for mistakes due to the original manuscript.
