Submission of a paper to the ACTA ORIENTALIA will be taken to imply that it represents original work not previously published, that it is not being considered elsewhere for publication, and that if accepted for

publication it will not be published elsewhere in the same form, in any language, without the consent of editor and publisher.

SUBMISSION

Authors should submit their manuscripts using the online manuscript submission and peer review *Open Journal System*. Details are available online at <https://submit.akademiai.com/aorient/index.php/aorient>.

PEER REVIEW CHARGE

No *peer review charge* applies.

REVIEW PROCESS

PREFERRED CONDITIONS OF MANUSCRIPTS

The ACTA ORIENTALIA strives to publish high quality papers. To ensure this goal, we apply some basic principles when reviewing a manuscript. Not fulfilling these principles may lead to desk rejection of a submitted manuscript.

REVIEW OF THE MANUSCRIPTS

As a routine, each paper will be read by at least two unbiased peer reviewers, chosen avoiding any conflict of interest. ACTA ORIENTALIA applies a double-blind review process, in which neither the authors' nor the reviewers' identities are revealed.

Unpublished results are treated strictly confidentially.

COPYRIGHT AND LICENCE POLICY

OPEN ACCESS

Authors of ACTA ORIENTALIA can optionally choose Open Access appearance. With this choice, readers can read, download, copy, distribute, print, search or link to the full texts of articles, or use them for any other non-commercial lawful purpose. Such articles are distributed under Creative Commons Attribution-NonCommercial 4.0 International Licenses.

Authors not choosing Open Access publication are expected to sign the Copyright Transfer Form available [here](#).

SELF-ARCHIVING

The Author is entitled to self-archive the preprint version of his/her manuscript. The preprint version is the Author's manuscript or the galley proof or the Author's manuscript along with the corrections made in the course of the peer review process. The Author's right to self-archive is irrespective of the format of the preprint (.doc,

.txt, .pdf) version and self-archiving includes the free circulation of this file via email or publication of this preprint on the Author's webpage or on the Author's institutional repository with open or restricted access. When self-archiving a paper, the Author should clearly declare that the archived file is not the final published version of the paper, he/she should quote the correct citation and enclose a link to the published paper ([http://dx.doi.org/\[DOI of the Article without brackets\]](http://dx.doi.org/[DOI of the Article without brackets])).

AUTHOR CHARGES

If choosing the optional Open Access appearance, corresponding author of every manuscript submitted after Feb 1, 2020 is requested to pay the *Article Processing Charge* (APC) of 900 EUR (including VAT) to cover the publishing costs of the paper.

In accordance with the agreement between the [Electronic Information Service National Programme](#) (EISZ) and Akadémiai Kiadó, papers with a corresponding author affiliated to a member institution subscribing to the journal package of Akadémiai Kiadó, can be published with no fee.

Akadémiai Kiadó offers 50% discount for Editorial Board members, and institutions of low- and middle-income countries. Discounts may not be combined. A limited number of waivers is available.

Manuscripts with outstanding payment will not be published until the balance is cleared. Once your paper is accepted for publication in ACTA ORIENTALIA, and the authors made the Open Access choice, you will be requested to enter our online payment platform (<http://apc.akademiai.hu>), where after registration You can upload license agreement and transfer the fee. Article processing will commence after the amount due has been remitted to our account. (Please note that there is no peer review charge, the only applicable fee is the article processing charge for authors of accepted papers who made the OA choice.)

ETHICAL STATEMENT

The ACTA ORIENTALIA and Akadémiai Kiadó are committed to the ethical practices in science publishing and therefore follow the COPE [Code of Conduct for Journal Editors](#) as well as the [Code of Conduct for Journal Publishers](#). All authors are expected to be aware and follow the [Ethical Guide of Akadémiai Kiadó](#), conform to the highest standards of ethical conduct in the submission of accurate data, acknowledging the work of others, and divulging potential conflicts of interests.

PREPARATION OF THE MANUSCRIPTS

MANUSCRIPTS

Papers should explore a narrow topic in philology, linguistics, literature or history of pre-modern Asia. They must be based on primary sources written in one or several Oriental languages and offer a new and relevant contribution to the respective field.

The text preferably adheres to the stylistic and bibliographic requirements outlined below. However, it is also possible to submit a paper without meeting these requirements, and implement these changes after the paper is accepted.

The file should be submitted in electronic form only, in both **.doc(x)** and **.pdf** formats.

AUTHOR INFORMATION

The paper itself must not contain the name of the author as author, and the author's name is also removed from the properties of the doc and pdf versions. The submitted paper is accompanied by a separate document (so-called *Cover letter*), which contains the author's name, affiliation, as well as email and postal addresses.

TEXT

The total length of the text (including illustrations, tables, etc.), unless agreed otherwise, should not exceed 35 typewritten pages. The first page should contain the title of the paper, the author's names and affiliations (full postal and e-mail address), an abstract, and keywords.

LANGUAGE

All papers submitted should be written in idiomatic academic English. If the author is not a native speaker, it is their responsibility to have the accepted paper checked by a native speaker (preferably prior to submission). Papers should follow British spelling and punctuation throughout.

ORIGINALITY AND EXISTING SCHOLARSHIP

Like all scholarly journals, **ACTA ORIENTALIA** accepts only papers that offer a new and relevant contribution to the respective field, and, more specifically, to the particular academic niche. This originality should be made clear and emphasised both in the abstract and in the paper itself. Authors should aim to make their argument in as clear and professional a fashion as possible; they should also find meaningful ways to engage with existing scholarship. An overview of former research and the main innovation proposed by the author should both be clearly stated in the first part of the paper, if possible, with new results to be found more extensively in the concluding part.

PHILOLOGY AND PRIMARY SOURCES

The primary focus of **ACTA ORIENTALIA** is on topics relating to the philology of pre-modern Asia (from the Near East to Japan), with a particular focus on Central Asia. Papers on modern, non-Asian or non-philological questions may be returned without further explanation. All submitted papers should be based on primary sources written in at least one Oriental language. The introduction of new textual sources and/or the English translation of previously untranslated Oriental texts are highly welcome; however, the translation should always be accompanied by a thorough analysis and contextualisation of the Oriental source in question. In exceptional cases (e.g. the introduction of new archaeological or visual sources, or highly innovative approaches), other topics may also be considered.

ABSTRACT

The submitted manuscripts should contain an abstract of max. 100 words, summarising the conceptual content and the new results of the paper.

KEYWORDS

The authors are kindly asked to add 6 to 8 keywords to their papers.

FIGURES AND TABLES

Graphs, line drawings, photographs and tables should be numbered in sequence using Arabic numerals, and their precise location should be identified in the text with a reference in brackets: e.g. "... as one can see on Guo Xi's painting (Fig. 7)" or "... (see Table 3)". Please send only high-quality photos and graphs, attaching these files separately. In the case of the online document, the number of colour images is not limited; however, authors are required to pay an addition subvention to have colour images published in the printed version.

FOOTNOTES

All footnotes must be placed on the same page as the text and numbered consecutively.

REFERENCES WITHIN THE PAPER

Within the text, works cited should be listed by author's name and year of publication, e.g. 'Doerfer and Tezcan (1980) claim that ...', or '... has already been demonstrated (Doerfer and Tezcan 1980)', or, if page numbers are cited, then: 'According to Doerfer and Tezcan (1980: 21–22)...'. In the case of publications from the same year, use letters to distinguish them: Doerfer and Tezcan (1980a, 1980b). If bibliographical items are referred to without any commentary or explanation, they must be placed in brackets in the main text; if the reference is complemented by additional information, it should be placed in the footnote. Between page numbers, always use an 'en dash' – (NOT the shorter hyphen - or the longer 'em dash' —), e.g.: Crowe 1998: 54–57. The same rule applies to dates, e.g. Ferdowsi (c. 940–1020).

REFERENCES AT THE END OF THE PAPER

Full citation of literature referred to should be given in an alphabetically arranged list at the end of the paper under the heading: References, further subdivided into 'Primary sources' and 'Secondary sources', if necessary. Please use the same character size and line spacing for references as for the text, and use small capitals (small caps) for the surname of the authors. In the references, please use full names of journals and series if they are not to be found in the list of abbreviations on the last pages of ACTA ORIENTALIA.

REFERENCE TO PAPERS IN JOURNALS:

Please write out the author's name (both surname and given name), and do not use dashes for further occurrences. In the case of three authors or editors, place an 'and' only before the last name; in the case of four or more authors or editors, use 'et al.' after the first name. Co-authored items come after single-authored ones, even if their publication date is earlier. All titles that are not in English, German, French, Italian or Russian should also appear in English and in square brackets after the original title, as in the following example:

SUN Weijie 孙伟杰 and GAI Jianmin 盖建民 2015. 'Huangdao shi'er gong yu daojiao guanxi kaolun 黄道十二宫与道教关系考论 [The relationship between the twelve signs of the Zodiac and Daoism].' *Zhongguo Zhexue shi 中国哲学史* 2015/3: 74–82.

Place Russian titles in normal alphabetical order, first providing a transcription of the name and the original (Cyrillic) name in square brackets, then giving the date and all other information in Cyrillic, as in the following example:

BASILOV, V. N. [БАСИЛОВ, В. Н.] 1986. 'Пережитки шаманства у туркмен гёкленов.' In: Владимир Н. БАСИЛОВ (ред.) *Древние обряды верования и культуры народов Средней Азии*. Москва: Наука, 94–109.

TRANSCRIPTION

The authors should use the transcription internationally accepted in their respective field of studies. Please try to avoid the use of special characters not found in TrueType fonts. Use Pinyin transcription in the case of Chinese unless you want to explain a linguistic reconstruction. If you have to use other special symbols, please attach a file containing the fonts (in the case of Chinese and Japanese, use MingLiu font).

PROOFS

The author will receive the first proof in a **.pdf** file. Please read and correct it carefully and return it promptly (within one week at the latest) to the copy editor. The corrections should be sent in a separate list with reference to the respective pages and lines.

ACCESS

Corresponding authors will gain free access to the electronic version of their paper after registration on the publisher's site akjournals.com.
