The journal accepts articles from every field of the legal sciences. Recently, the editors have encouraged contributions from outside Hungary, with the aim of covering the legal sciences in the whole of Central and Eastern Europe. HUNGARIAN JOURNAL OF LEGAL STUDIES publishes book reviews as well. The journal's language is English.

EDITORIAL BOARD INFORMATION

HUNGARIAN JOURNAL OF LEGAL STUDIES was founded in 1959 by the Hungarian Academy of Sciences. Until 1990, it was published with the title ACTA JURIDICA ACADEMIAE SCIENTIARUM HUNGARICAE; and in the period 1990-2015 as ACTA JURIDICA HUNGARICA. Its publisher is Akadémiai Kiadó, Budapest, Hungary.

SUBMISSION INFORMATION

Submission of a paper to the HUNGARIAN JOURNAL OF LEGAL STUDIES will be taken to imply that it represents original work not previously published, that it is not being considered elsewhere for publication, and that if accepted for publication it will not be published elsewhere in the same form, in any language, without the consent of editor and publisher.



Instructions for Authors

SUBMISSION

The Editors require that all submissions be made via the online submission platform *Open Journal System (OJS)*. Using this system, registered authors can upload manuscript files (texts, figures, tables) directly to the own account https://submit.akademiai.com/hjls/index.php/hjls of the HUNGARIAN JOURNAL OF LEGAL STUDIES and check the status of their manuscripts during the review process. The authors can also receive e-mail notifications of any changes to the status of their manuscripts if they choose this option in their notification settings. In addition, reviewers can access their manuscripts (in a highly secure fashion that maintains referee anonymity) over a direct internet link, which speeds up the review process. The manuscripts will be processed by the online submission system only after the acceptance of the HUNGARIAN JOURNAL OF LEGAL STUDIES's Data Processing Policy and the Copyright Transfer Statement (see below).

PEER REVIEW CHARGE

No peer review charge applies.

REVIEW PROCESS

PREFERRED CONDITIONS OF MANUSCRIPTS

The HUNGARIAN JOURNAL OF LEGAL STUDIES strives to publish high quality papers. To ensure this goal, we apply some basic principles when reviewing a manuscript. Not fulfilling these principles may lead to desk rejection of a submitted manuscript.

REVIEW OF THE MANUSCRIPTS

The complete review process for the HUNGARIAN JOURNAL OF LEGAL STUDIES is double-blind and undertaken through the journal's online submission system. The assignment of the reviewers is made by the Editors.

The Editor-in-Chief ensures the absolute confidentiality of the whole process.

The decision after the first round of reviewing can be:

- 1. acceptance of the paper without further corrections,
- 2. acceptance of the paper with corrections and changes suggested by the reviewers and the Editors,
- request of major changes (following the completion of the suggested corrections by the author(s) and
 the resubmission of the revised article, the paper will be returned to the reviewers for a second round
 of review), or a suggestion that the paper should be completely rewritten along some well-specified
 guidelines, and
- 4. outright rejection.

The authors will be informed about the decision via email and through the online submission system. In order to increase the effectiveness of the review process, authors are kindly asked to respond timely to the comments and suggestions of the reviewers and the Editors. The Editors make the final decision on acceptance or rejection based on the reviewers' reports and on their own judgment.

COPYRIGHT AND LICENCE POLICY

OPEN ACCESS

All articles of HUNGARIAN JOURNAL OF LEGAL STUDIES can be accessed openly two years after the date of their publication at the journal's website.



Instructions for Authors

Authors of HUNGARIAN JOURNAL OF LEGAL STUDIES can optionally choose (immediate) Open Access appearance. With this choice, readers can read, download, copy, distribute, print, search or link to the full texts of articles, or use them for any other non-commercial lawful purpose. Such articles are distributed under Creative Commons Attribution-NonCommercial 4.0 International Licenses.

The Open Access Licence Agreement form can be downloaded from here (and a slightly modified variant <a href=here; for those authors who are eligible for Open Access publication through the EISZ consortial agreement, see below).

Authors not choosing Open Access publication are expected to sign the Copyright Transfer Form available here.

SELF-ARCHIVING

The Author is entitled to self-archive the preprint version of his/her manuscript. The preprint version is the Author's manuscript or the galley proof or the Author's manuscript along with the corrections made in the course of the peer review process. The Author's right to self-archive is irrespective of the format of the preprint (.doc, .txt, .pdf) version and self-archiving includes the free circulation of this file via email or publication of this preprint on the Author's webpage or on the Author's institutional repository with open or restricted access. When self-archiving a paper, the Author should clearly declare that the archived file is not the final published version of the paper, he/she should quote the correct citation and enclose a link to the published paper (http://dx.doi.org/[DOI of the Article without brackets]).

AUTHOR CHARGES

If choosing the optional Open Access appearance, corresponding author of every manuscript submitted after Feb 1, 2020 is requested to pay the *Article Processing Charge* (APC) of 900 EUR (including VAT) to cover the publishing costs of the paper.

In accordance with the agreement between the <u>Electronic Information Service National Programme</u> (EISZ) and Akadémiai Kiadó, papers with a corresponding author affiliated to a member institution subscribing to the journal package of Akadémiai Kiadó, can be published with no fee.

Akadémiai Kiadó offers 50% discount for Editorial Board members, and institutions of low- and middle-income countries. Discounts may not be combined. A limited number of waivers is available.

Manuscripts with outstanding payment will not be published until the balance is cleared. Once your paper is accepted for publication in HUNGARIAN JOURNAL OF LEGAL STUDIES and the authors made the Open Access choice, you will be requested to enter our online payment platform (http://apc.akademiai.hu), where after registration You can upload license agreement and transfer the fee. Article processing will commence after the amount due has been remitted to our account. (Please note that there is no peer review charge, the only applicable fee is the article processing charge for authors of accepted papers who made the OA choice.)

Instructions for Authors

PREPARATION OF THE MANUSCRIPTS

The HUNGARIAN JOURNAL OF LEGAL STUDIES publishes original research papers, review articles, book reviews and announcements in the field of legal sciences. The Editors encourage contributions from outside of Hungary, with the aim of covering the legal sciences in the whole of Central and Eastern Europe.

INGREDIENTS

Online submissions should include a *biography* of the author(s), a *title page*, a *manuscript text*, and (optionally) *figure* or *table* documents, all in separate files.

BIOGRAPHY OF THE AUTHOR(S)

Biography of the author(s) should not exceed 200 words. The style should conform to that used in former HUNGARIAN JOURNAL OF LEGAL STUDIES volumes.

TITLE PAGE

The title page should contain the first name(s) and the surname of the author(s), the title of the manuscript, and the name of the institution the author works at. The postal address, email address, and fax number of the corresponding author must also be indicated.

MANUSCRIPT TEXT FILE

Manuscripts should be written in clear, concise, and grammatically correct English. HUNGARIAN JOURNAL OF LEGAL STUDIES uses Oxford English spelling. The printout of the manuscript text should be typed double-spaced (on one side of the paper in printouts), with wide margins. The order in the text should be as follows: title, abstract, keywords, text with footnotes.

Advertisements may only be inserted by the Publisher.

Please, do not indicate your name and any of your personal data in the manuscript text file in order to facilitate the anonymous review process.

TITLE

The title should be concise and informative, and not longer than 60 characters.

ABSTRACT

The abstract should not exceed 200 words. The authors will be asked to copy the abstract in the indicated field during the online submission procedure.

KEYWORDS

The number of keywords should not exceed 5.

ACKNOWLEDGEMENTS

The optional acknowledgements should be brief, and should not include thanks to anonymous reviewers and Editors, or effusive comments. Grant or contribution numbers may be acknowledged.

Instructions for Authors

Manuscript texts should use footnotes, not endnotes. The references should follow the "The Oxford University Standard for Citation of Legal Authorities" (OSCOLA) with some important modifications:

- 1. There is always a list of the referred literature at the end of the papers.
- 2. There are **no** full references and cross-citations in the footnotes. In the footnotes only three main data are given:

author | (year) | page.

CITATION IN THE FOOTNOTES

These examples show the citations of a book (for edited books and articles see citation in the *Literature* below) which is given in full in the *Literature* at the end of the paper and cited first in footnote 26 and again in footnote 27.

At the end of your paper, in the list of referred *Literature* you should cite the referred material in Alphabetical Order as following:

BOOKS

author, | title | (additional information, | edition, | publisher | year)

Examples:

Burrows, A., Remedies for Torts and Breach of Contract (3rd edn, OUP 2004).

von Bar, Ch., The Common European Law of Torts, vol 2 (CH Beck 2000).

WORKS IN EDITED BOOKS

author, | 'title' | in editor (ed), | book title | (additional information, | publisher | year) starting and ending pages.

JUDGMENTS OF THE EUROPEAN COURT OF HUMAN RIGHTS

For judgments of the European Court of Human Rights (ECtHR), cite either the official reports, the Reports of Judgments and Decisions (cited as ECHR) or the European Human Rights Reports (EHRR), but be consistent in your practice.

Examples:

Johnston v Ireland (1986) Series A no 122.

Osman v UK ECHR 1998-VIII 3124.

Balogh v Hungary App no 47940/99 (ECtHR, 20 July 2004).

Omojudi v UK (2010) 51 EHRR 10.

TABLES

Each table, bearing a title, should be self-explanatory and processed in separate file(s) in the online submission system. Their approximate position should be indicated in the manuscript text file and numbered consecutively with Arabic numerals.

FIGURES

Figures should also be submitted through the online submission system in **TIFF** or **JPG** file format (min. 300 dpi) in separate file(s). Excel files with edited diagrams and charts are only accepted in the original data file (e.g. **xls**, **xlsx**, etc.). Please only use black and white colours. In the legend use different signs, not colours. All figures should be numbered consecutively with Arabic numerals and their approximate positions should be indicated in the manuscript text. It is the responsibility of the author to obtain written permission for the reprint of all quotations, illustrations, figures, and tables.

PROOF

Online page proofs for author's approval or corrections are requested to be returned within 48 hours from receipt. Please note that authors are urged to check their proofs carefully before submitting corrections, since late corrections cannot be guaranteed for inclusion and post-publication corrections are only possible in an erratum. Corrections to the proofs must be restricted to existing errors. Rewriting the text or modifying authorship is not accepted in the proof stage.

AUTHORS' ACCESS TO THE PUBLISHED PAPER

Free online access is provided to the corresponding author after registration on the publisher's platform akjournals.com. More information about the process is available here.
