The journal's language is English.

Submission of a paper to ACTA CHROMATOGRAPHICA will be taken to imply that it represents original work not previously published, that it is not being considered elsewhere for publication, and that if accepted for publication it will not be published elsewhere in the same form, in any language, without the consent of editor and publisher. Submissions are to be accompanied by a signed statement thereof (see links to the License Agreement forms under section COPYRIGHT AND LICENSE POLICY/OPEN ACCESS below).

REVIEW PROCESS

PREFERRED CONDITIONS OF MANUSCRIPTS

The ACTA CHROMATOGRAPHICA strives to publish high quality papers. To ensure this goal, we apply some basic quality and relevance criteria when reviewing a manuscript. Please make sure that all quotations are duly marked and referenced, bearing in mind that the manuscript might undergo plagiarism screening.

REVIEW OF THE MANUSCRIPTS

Upon submission, the manuscript is preliminarily assessed by Editor-in-Chief for its conformity with general recommendations regarding the correct format. These recommendations are clearly itemized under section PREPARATION OF THE MANUSCRIPTS below and they should be attentively read and strictly followed in the course of manuscript preparation. Only then, the manuscript is taken over by Editor-in-Chief or Section Editor for the surveillance of an entire evaluation process. Editor in charge of this process undertakes an ultimate decision regarding an acceptance (or otherwise) of the manuscript considered. Evaluation is based on at least two single-blind evaluation reports performed by unbiased peer-reviewers, chosen avoiding conflict of interest. ACTA CHROMATOGRAPHICA applies a single-blind review process, in which the reviewers' identities are hidden to the authors while the reviewers are aware of the authors' identities.

In order to assist the evaluation process, Authors are encouraged to suggest or exclude Reviewers, however, an ultimate selection of the Reviewers always remains a prerogative of the Editor in charge of the manuscript considered. Suggested reviewers may not be in any way affiliated with the author or the work. Authors should provide academic email addresses of the proposed reviewers.

Unpublished results are treated strictly confidentially.

OPEN ACCESS

ACTA CHROMATOGRAPHICA is a Gold Open Access journal. Readers can read, download, copy, distribute, print, search or link to the full texts of all articles, or use them for any other (non-commercial) lawful purpose, immediately after publication. All articles are distributed under *Creative Commons Attribution 4.0* or *Creative Commons Attribution-NonCommercial 4.0* International Licenses (for more details see COPYRIGHT AND LICENSE POLICY below).

- there is no plagiarism in the article, the content is punctual and true to the best of the Author's knowledge, it does not include any libel, or parts that are obscene or violate the copyrights, private life or any other rights of a third party, or that are illegal and shall warrant that the manuscript is not partly or entirely under review or being published at any other journals either in English or in any other languages,
- the Author shall accept that he/she shall provide the exact location of the first publication of the article when making the article available to any third party and shall enclose the link to the location of the first publication in the following format: (<https://doi.org/> [The DOI-number of the article without brackets]).

ARTICLE PROCESSING CHARGE

The corresponding author of every manuscript submitted after Feb 1, 2020 and not covered by the agreement between EISZ and Akadémiai Kiadó is requested to pay the *Article Processing Charge* (APC) of EUR 400.00 (including VAT) to cover the publishing costs of the paper.

Authors without a waiver will be requested – after acceptance of their paper in ACTA CHROMATOGRAPHICA – to enter our online payment platform (<https://apc.akademiai.com>), where after registration they can upload the license agreement and settle the fee by bank transfer or with a credit card. Manuscripts with outstanding payment will not be processed until the balance is cleared.

Please note that there is no peer review charge, the only applicable fee is the article processing charge.

EISZ READ AND PUBLISH AGREEMENT

In accordance with the agreement between the [Electronic Information Service National Programme](#) (EISZ) and Akadémiai Kiadó, papers with a corresponding author affiliated to a member institution subscribing to the journal package of Akadémiai Kiadó will be published without an author fee (APC).

WAIVERS

A limited number of full waivers is available, that is, the editor-in-chief may waive the APC to authors of selected articles. If you wish to request a partial or full waiver, please do so *before* submitting your manuscript. Requests for a waiver initiated after acceptance will be rejected without consideration.

DISCOUNTS

Akadémiai Kiadó offers a 50% discount for Editorial Board members, and to authors affiliated with institutions in [lower-middle-income countries](#), whereas authors from [low-income economy](#) institutions would be granted a 100% discount. Discounts may not be combined.

ETHICAL STATEMENT

ACTA CHROMATOGRAPHICA and Akadémiai Kiadó are committed to the ethical practices in science publishing and therefore follow the COPE [Code of Conduct for Journal Editors](#) as well as the [Code of Conduct for Journal Publishers](#). All authors are expected to be aware and follow the [Ethical Guide of Akadémiai Kiadó](#), conform to the highest standards of ethical conduct in the submission of accurate data, acknowledging the work of others, and divulging potential conflicts of interests.

PREPARATION OF THE MANUSCRIPTS

ACTA CHROMATOGRAPHICA publishes *Review Papers*, *Original Research Papers* and *Short Communications*.

Review Papers: These papers are typically between 40 and 50 pages in length, including tables, figure captions and references. The references, tables, and figure captions should be typed, in that sequence, on separate pages after the text of the paper. Pages should be numbered, including those with the table and figure captions. Review papers should be dedicated to issues of broader interest for the chromatographic research community and they should embrace the areas of chromatographic analysis as well as sample preparation.

Original Research Papers: These papers are typically between 10 and 20 pages in length, including tables, figure captions, and references. The manuscripts should be prepared analogously to Reviews and they should present original research from the areas of chromatographic analysis as well as sample preparation.

Short Communications: The main purpose of this type of paper is rapid communication of brief (between 2 and 6 pages), often preliminary, research results.

MANUSCRIPTS

Manuscripts should be written in clear, concise, and grammatically correct English. The order should be as follows: *title page, abstract and keywords, text, appendix, acknowledgements, notes, references, tables, figures, figure captions.*

Please submit your manuscript on ONE FILE ONLY, preferably in DOC/DOCX.

TITLE AND AUTHORS

The *title* should be concise and informative. Abbreviations in the title should be avoided.

After the title, list the authors and give their affiliations and addresses. Mark with an asterisk the author to whom correspondence should be addressed.

ABSTRACT AND KEYWORDS

Always include an abstract summarising the manuscript, typed on a separate page. Please add several (2–5) keywords relevant to the content of the paper.

TEXT

The main text must begin on page 3. The following subdivisions should normally be adhered to: *Introduction, Experimental, Results and Discussion, Conclusion* (where appropriate), *References, Tables* (one per page), *Figures* (one per page), and *Captions*.

ACKNOWLEDGEMENT

You may add an optional *Acknowledgements* section for any further information you wish to disclose.

FOOTNOTES

should only be used if absolutely necessary.

REFERENCES

in the text should be indicated by sequential numbers in square brackets (not superscripts) and listed in the same manner. Please do not use the Word endnotes or footnotes features. References should conform to the ACS Style Guide. Examples of the correct listing are given below:

TABLES

Each, bearing a title, should be self-explanatory. They should all be mentioned in the text, numbered consecutively with Arabic numerals and placed on separate sheets at the end of the manuscript, following the *References*.

FIGURES

Please submit figures incorporated in the manuscript file, with a minimum of 600 dpi. Figures must be prepared in *.JPG, *.TIF or *.BMP format, and numbered in order of citation in the text. All figures should be mentioned in the text.

When submitting large figures please take into consideration that line width and – if text is included – font size will decrease when the size of the figure is reduced to the column width. The most suitable fonts – because they are the most easily readable – are Arial and Swiss ('sans serif' fonts). Please do not include unnecessary text in figures – include as much as possible in the figure caption.

Line widths in the figures should not be less than 0.2 mm after eventual reduction. Please omit outer lines (frames around figures) and background lines.

When including several figures with a manuscript, please strive for uniformity. The figures should be placed together, after the text, just like an enclosure, one figure per page. We encourage authors to send high-resolution colour chromatograms, images, charts, etc. – all these will be published in colour.

Figure captions should be typed double-spaced on a separate page. The location of the figures in the text should also be clearly indicated.

ADVERTISEMENTS

may be inserted at the rates of the Publisher.

PROOF

Online page proofs for checking are requested to be returned within three working days of receipt. Please note that authors are urged to check their proofs carefully before submitting corrections, since late corrections cannot be guaranteed for inclusion and post-publication corrections are only possible in an erratum. Corrections to the proofs must be restricted to existing errors. Rewriting the text or modifying authorship is not accepted in the proof stage.
