Major focus is on infections caused by pathogenic bacteria and parasites; molecular mechanisms of pathogenicity; host pathogen interaction; innate and adaptive immunity to infection and antimicrobial chemotherapy. The types of published papers are reviews, original articles, results of prospective randomized trials, case studies, and PhD-theses summaries. The journal's language is English.

REVIEW PROCESS

PREFERRED CONDITIONS OF MANUSCRIPTS

The EUROPEAN JOURNAL OF MICROBIOLOGY AND IMMUNOLOGY strives to publish high quality papers. To ensure this goal, we apply some basic originality and quality criteria when reviewing a manuscript. Not fulfilling these criteria may lead to desk rejection of a submitted manuscript.

REVIEW OF THE MANUSCRIPTS

Each paper will be read by at least two unbiased peer reviewers, chosen avoiding any conflict of interest. EUROPEAN JOURNAL OF MICROBIOLOGY AND IMMUNOLOGY applies a single-blind review process, in which the reviewers' identities are hidden to the authors while the reviewers are aware of the authors' identity. Papers accepted for publication by the Editorial Board are subject to editorial revision. Unpublished results are treated strictly confidentially.

COPYRIGHT AND LICENCE POLICY

OPEN ACCESS

EUROPEAN JOURNAL OF MICROBIOLOGY AND IMMUNOLOGY is a Gold Open Access journal. Readers can read, download, copy, distribute, print, search or link to the full texts of all articles, or use them for any other non-commercial lawful purpose. All articles are distributed under Creative Commons Attribution-NonCommercial 4.0 International Licenses.

ETHICAL STATEMENT

EUROPEAN JOURNAL OF MICROBIOLOGY AND IMMUNOLOGY and Akadémiai Kiadó are committed to the protection of animal and human research subjects and ethical practices in science publishing and therefore studies submitted to the journal must have been conducted in accordance with all applicable local and international standards. Akadémiai Kiadó follows the guidelines in the COPE [Code of Conduct for Journal Editors](#) as well as the [Code of Conduct for Journal Publishers](#). All authors are expected to be aware and follow the [Ethical Guide of Akadémiai Kiadó](#), conform to the highest standards of ethical conduct in the submission of accurate data, acknowledging the work of others, and divulging potential conflicts of interests.

All empirical studies must have a short description on the ethics regarding the study whose form is specified in the section about requirements on the manuscripts below.

AUTHORSHIP

All persons designated as authors should qualify for authorship. Each author should have participated sufficiently in the work to take public responsibility for the content. The corresponding author affirms that he or she had access to all data from the study, both what is reported and what is unreported, and also that he or she had complete freedom to direct its analysis and its reporting, without influence from the sponsors. The corresponding author also affirms that there was no editorial direction or censorship from the sponsors. Preparation of drafts of manuscripts by employees of the sponsor who are not listed as authors is expressly prohibited.

DISCLOSURE OF FINANCIAL RELATIONSHIPS

Disclosure of financial relationships is required at the time of submission and provisional acceptance of all manuscripts, including original articles, reviews, and case studies. The authors are responsible for informing the Journal of any additional financial relationships that may arise prior to the date of publication of their paper. Financial support for the study is always disclosed at the end of the manuscript (before the References), whether from governmental, non-profit, or commercial sources. Non-financial forms of support, such as drugs, analytic support, or other assistance with preparation of the manuscript, must also be acknowledged. All authors must individually disclose all financial relationships, whether or not directly related to the subject of their paper. Such reporting must include all equity ownership, profit-sharing agreements, royalties, patents, and research or other

grants from private industry or closely affiliated non-profit funds. For income from pharmaceutical companies, the purpose must be specified. Reporting should encompass the previous 36 months. If an author has no interests to disclose, this must be explicitly stated. The Editors will review all author statements of financial support to determine if there is evidence of bias from these sources. If it appears that there may be, then further review and possible rejection of the manuscript may occur. Authors are encouraged to contact the Editor at any stage in the manuscript review process if they believe that they have relationships that require review.

PERMISSIONS

It is the responsibility of the author(s) to obtain written permission for quotations, and for the reprinting of illustrations or tables.

PREPARATION OF THE MANUSCRIPTS

Manuscripts should be written in clear, concise, and grammatically correct English.

The manuscript should be submitted in Word for Windows file.

The order of sections should be as follows: *title page, abstract, keywords, text, funding sources, authors' contributions, conflicts of interest, acknowledgements, supporting information, notes, references, figure captions.*

TITLE

should be a clear and concise statement of the contents in not more than 20 words. This is followed by the authors' full name, and the name of the institutions where the work has been done. The mailing address, e-mail address (optionally phone and fax numbers) of the corresponding author must also be given in a footnote to the first page.

ABSTRACT

should not exceed 200 words and should briefly outline the purpose, results (new findings supported by data) and conclusions of the study. Citations are to be avoided in the abstract.

KEYWORDS

should be added in a number between 5 and 10.

THE TEXT

of the paper should be divided into **sections** with the headings: *Introduction, Materials and Methods, Results, Discussion, Funding sources, Authors' contributions, Conflicts of interest, Acknowledgements, Supporting information, References.*

INTRODUCTION

should state briefly the nature, purpose, and reasoning of the work and cite recent important work by others.

ETHICS

All empirical studies must have a short description on the ethics regarding the study. This should be placed at the very end of the *Methods* section, under a separate subheading of *Ethics*. It should contain information on the *ethical approval* of the study by the Institutional Review Board and – where applicable – the *informed consent*

(or parental consent for those younger than 18 years of age) given by the participants of the study. If approval was not obtained, authors must explain why it was not required.

Ethics

The study procedures were carried out in accordance with the *Declaration of Helsinki*. The Institutional Review Board of the [Name of the Institute] approved the study. All subjects were informed about the study and all provided informed consent. (If applicable: Parental consent was sought for those younger than 18 years of age.)

Approval from the relevant body is required for studies involving:

- Humans (either live or tissue), such as studies that are observational, survey-based, or include any personal data;
- Animals (either live or tissue), such as observational studies;
- Commercially unavailable cell lines;
- Field sampling;
- Potential biosafety implications.

STATEMENTS

At the end of the manuscript, before the *References* section, please add the following statements:

FUNDING SOURCES: State even if no funding was obtained by writing “Nothing declared” or “No financial support was received for this study” or any other similar statement.

AUTHORS’ CONTRIBUTION: Please specify each author’s contribution to the manuscript. Use the monograms of the authors and specify their roles in preparing the manuscript. You may use the following roles: study concept and design, analysis and interpretation of data, statistical analysis, obtained funding, study supervision, or any other specific role. Also state whether all authors had full access to all data in the study and take responsibility for the integrity of the data and the accuracy of the data analysis.

CONFLICT OF INTEREST: All authors are requested to disclose any actual or potential conflict of interest including any financial, personal or other relationships with other people or organizations within three years of beginning the work submitted that could inappropriately influence, or be perceived to influence, their work. Also state if no conflict of interest was present by writing “The authors declare no conflict of interest” or “The authors report no financial or other relationship relevant to the subject of this article” or any other similar statement.

You may add an optional **ACKNOWLEDGEMENTS** section for any further information you wish to disclose.

REFERENCES

in the text should be cited by names only if they are part of the sentence: “Hilton [5] described earlier...,” otherwise they should be indicated by the reference number(s) in square brackets [3, 7, 12]. If there are more than two authors, the name of the first author should be used, followed by “et al.” List the references in order of appearance at the end of the paper. The style and punctuation of references should conform to that used in the journal, which is following the recommendations of MEDLINE/PubMed (for further details see https://www.nlm.nih.gov/bsd/uniform_requirements.html).

ABBREVIATIONS AND SYMBOLS

All abbreviations should be spelled out when first used in the text. Please highlight unusual symbols on the margin. Quantities should be expressed in SI units.

FOOTNOTES

should only be used if absolutely necessary.

TABLES

should be comprehensive to the reader without reference to the text. They should be submitted as separate files and have a concise heading each typed above the table. Tables are numbered consecutively with Arabic numerals. All tables should be referred to in the text, in consecutive order.

FIGURES

(line drawings, diagrams, photographs) should be numbered consecutively with Arabic numerals and submitted as separate files, as JPEG or TIFF. All figures should be referred to in the text, in consecutive order.

PROOF

Online page proofs for author's approval or corrections are requested to be returned within 48 hours from receipt. Please note that authors are urged to check their proofs carefully before submitting corrections, since late corrections cannot be guaranteed for inclusion and post-publication corrections are only possible in an erratum. Corrections to the proofs must be restricted to existing errors. Rewriting the text or modifying authorship is not accepted in the proof stage.
