## Instructions for Authors

### AIMS AND SCOPE

MATHEMATICA PANNONICA is a peer-reviewed mathematical journal devoted to the publication of high-quality research papers on pure and applied mathematics.

The idea of launching a high level international mathematical journal in Austrian-Hungarian cooperation stems from late professors I. Gy. Maurer (1927-2012, Hungary) and H. Sachs (1942-2013, Austria). As a result of their initiative the first volume of Mathematica Pannonica was published in 1990. One year later, in 1991, professor G. Tironi (Italy) joined the "Founding Fathers" and the journal has become a truly "Pannon" scientific journal (comprising the historical regions of the ancient *Pannonia Inferior* and *Pannonia Superior*). The aim of launching this journal was emphasized in the Editorial Preface of the first issue as reads:

*"Our primary aim is to serve the mathematical community. At the same time, it is not a secret that by organizing this journal we wish to contribute to the upgrading of the once flourishing network of cultural ties in the Central European Region."*

This specific aim has unquestionably been reflected in the composition of the Editorial Board of the journal in the past two decades.

The journal's language is English.

### EDITORIAL BOARD INFORMATION

MATHEMATICA PANNONICA was founded in 1990 by late professors I. Gy. Maurer and H. Sachs. Since 2021, its owner and publisher is Akadémiai Kiadó, Budapest, Hungary.

### EDITORIAL BOARD

MATHEMATICA PANNONICA is handled by an independent Editorial Board of autonomous scholars. Free from any external influence, they decide about the journal's policies in general, and – based on the outcome of a peer review – about the acceptance of papers in each concrete case. ### PUBLICATION SCHEDULE

One volume of two issues is published in every year.

### DIGITAL ARCHIVE

The entire journal content is archived in the [Portico](#) preservation archive.

### SUBMISSION INFORMATION

Submission of a paper to the MATHEMATICA PANNONICA will be taken to imply that it represents original work not previously published, that it is not being considered elsewhere for publication, and that if accepted for publication it will not be published elsewhere in the same form, in any language, without the consent of editor and publisher. All submissions will be checked for possible instances of plagiarism and self-plagiarism.

### SUBMISSION

### PEER REVIEW CHARGE

No *peer review charge* applies.

### REVIEW PROCESS

#### PREFERRED CONDITIONS OF MANUSCRIPTS

The MATHEMATICA PANNONICA strives to publish high quality papers. To ensure this goal, we apply some basic principles when reviewing a manuscript. Not fulfilling these principles may lead to desk rejection of a submitted manuscript.

#### REVIEW OF THE MANUSCRIPTS

As a routine, each paper will be read by at least one unbiased peer reviewer, chosen avoiding any conflict of interest. MATHEMATICA PANNONICA applies a single-blind review process, in which the authors' identities are known to the reviewer but the reviewers' identities are not revealed.

Unpublished results are treated strictly confidentially.

### COPYRIGHT AND LICENCE POLICY

#### OPEN ACCESS

MATHEMATICA PANNONICA is a Gold Open Access journal. Readers can read, download, copy, distribute, print, search or link to the full texts of articles, or use them for any other non-commercial lawful purpose. All articles are distributed under Creative Commons Attribution-NonCommercial 4.0 International Licenses.

### LICENCE POLICY

By default, the articles are published under the *Creative Commons Attribution-NonCommercial 4.0* International Licenses Copyright Terms. With that, the authors grant to Akadémiai Kiadó Zrt. (hereafter the Publisher) an irrevocable nonexclusive license to publish the article in electronic and print format, and further sublicense the article in its original language throughout the world. The Publisher has the exclusive right to publish the article first.

The Author shall declare and warrant that

- he/she is the exclusive author of the article along with the above indicated co-authors and he/she has the approval of all the other co-authors to publish the article in its current form,
- the article is their own intellectual product,
- the article is original, has not been formally published in any other peer-reviewed journal, is not under consideration by any other journal and does not infringe any existing copyright or any other third-party rights,
- there is no plagiarism in the article, the content is punctual and true to the best of the Author's knowledge, it does not include any libel, or parts that are obscene or violate the copyrights, private life or any other rights of a third party, or that are illegal and shall warrant that the manuscript is not partly or entirely under review or being published at any other journals either in English or in any other languages,
- the Author shall accept that he/she shall provide the exact location of the first publication of the article when making the article available to any third party and shall enclose the link to the location of the first publication in the following format: (<https://doi.org/> [The DOI-number of the article without brackets]).

The Publisher shall be entitled to the following – not exclusive - rights of use after the first publication:

- To make the article available to the public for download on their own official publisher webpage without any time restriction.
- To utilize the article for commercial purposes individually or for the entire journal without any geographic or time limitation (for subscribers, one-off downloaders, one-off buyers of the article archive, etc.).
- To convert the article into the optional electronic format, to copy the article on a PC or electronic data medium.
- To publish the article in the electronic and printed journals indicated on the official publisher homepage, also including those journals that are partially or entirely available to a third party against a subscription fee.

## PREPARATION OF THE MANUSCRIPTS

Papers are accepted only in the case of *proper grammatical use of English*.

## MANUSCRIPTS

Authors are encouraged to prepare their manuscripts using BiBTeX and MATHEMATICA PANNONICA’s own LaTeX style **MathPannX.cls**. The style file and the template can be downloaded from [here](#).

*Shorter* articles (of not more than 12 typewritten pages long) and those likely be *accessible* to a wide range of mathematicians will be given *preferential consideration* by the Editorial Board.

Authors are asked to enclose:

- 1) *AMS Subject Classification*;
- 2) *Keywords*;
- 3) *Abstract*;
- 4) an *Abstract* for Zentralblatt für Mathematik.

Authors are encouraged to mark widely/commonly accepted mathematical notions in their paper by writing them in *italics*, while notions initiated/introduced in the paper by sansserif.

References should be listed in an *alphabetical order*, preferably according to the following pattern:

### FOR A PAPER IN A JOURNAL:

COHN, P. M.: An embedding theorem for free associative algebras, *Mathematica Pannonica* 1, 1 (1990), 49–56;

### FOR A BOOK:

BLASCHKE, W.: *Ebene Kinematik*, Oldenburg, München, 1956.
